10. No exhibit may block or interfere with other exhibits.
11. Exhibitor agrees to remain set up during all exhibition hours. No Early breakdowns or exhibits are allowed without prior consent of the show promoters.
12. Move OUT TIME:  
All property must be removed from the premises Sunday by 8:00 p.m. or on Monday between 8:30 a.m. and 11:00 a.m.  
There will be no dismantling of booths allowed during show hours. Large warehouse carts are available to move your merchandise. Vehicles are to be moved from loading areas promptly after loading and unloading is completed.
